REGISTRATION AND ENROLLMENT

Our program is open to children 18 months through 5 years as of September 1st of the current school year.

Enrollment is open to parishioners of St. Anthony's, as well as members of the surrounding community.

CLASS CHOICES

The following classes are offered for the 2017-2018 school year. Class schedules are subject to change.

Toddlers (18-30 months by 9/1/17):

Tuesday & Thursday, 9 a.m.— 2 p.m.

Twos (24-35 months by 9/1/17):

Monday, Wednesday, & Friday, 9 a.m.— 2 p.m. or
Tuesday & Thursday, 9 a.m.— 2 p.m.

Threes (3 years by 9/1/17):

Monday, Wednesday, & Friday, 9 a.m.— 2 p.m. or
Tuesday & Thursday, 9 a.m.— 2 p.m.

Fours (4 years by 9/1/17) :

Monday, Wednesday, & Friday, 9 a.m.— 2 p.m. or
Tuesday & Thursday, 9 a.m.— 2 p.m.

Transition (5 years by 9/1/17):

Monday through Friday, 9 a.m.— 2 p.m.

TUITION & FEES:

\$3,455/year MWF class
\$2,535/year TTH class
\$5,370/year Transition

Installment amounts are:

\$384/month MWF class
\$281/month TTH class
\$597/month Transition

Registration Fee: \$125 per student

Registration Fee is non-refundable, non-transferable and due at the time of registration.

Supply Fees:

\$160/year MWF class
\$110/year TTH class
\$210/year Transition

First tuition payment and supply fees are due by:

May 15, 2017

Tuition payments are then due on the 1st of each month September-April. A 30-day written notice of cancellation must be received if a child is leaving the program. The last month's tuition will be retained if notice is not received.



CALENDAR

Our program will coordinate with the Conroe ISD calendar for holidays and vacations. A copy of our calendar is provided to you and available on-line.

WHAT TO BRING & WEAR:

All children must have a bag that fits a regular size folder. Each item in the bag must be labeled with the child's name. A complete change of clothes including shoes and socks must be in your child's bag. Diapers, wipes, pacifiers, cups & comfort items should be in your child's bag labeled. Parents should also supply a nutritious snack and a well-balanced lunch.

Clothing should be comfortable and appropriate for "messy" activities such as painting and outdoor play. **Close-toed tennis shoes are required.**

DISCIPLINE POLICY

We believe that children learn best through positive experiences. We will work to provide a positive environment by praising good citizenship, anticipating/eliminating potential problems, structuring the environment and schedule to maximize the child's potential, using natural and logical consequences. Corporal punishment in any form will not be condoned in our facility.
